<u>Objective</u>: To provide the Communities Scrutiny Panel with information on how the East Leicestershire & Rutland Clinical Commissioning Group is utilising Section 106 funding to manage impact of growth in patient population resulting from housing developments.

- 1. Outcome sought from Panel
- 1.1 Overview and scrutiny of the East Leicestershire & Rutland Clinical Commissioning Group with regards to the delivery of s106 planning obligations for health.
- 2 Background
- 2.1 The East Leicestershire and Rutland Clinical Commissioning Group (ELRCCG) through its delegated responsibility of Commissioning General Medical Services has an obligation to consider and feed into local developments that potentially may have an impact on how GP Practices deliver care to their local population.
- 2.2 On 27th September 2018 the Communities Scrutiny Panel received a report on S106 planning obligations for health. This report gave an overview of s106 planning obligations for health and highlighted the importance of the ELRCCG engaging with Harborough District Council to ensure health infrastructure needs are taken into account in the planning process. The report covered;
 - the amount received by the NHS from individual schemes;
 - the mechanism by which the money is collected;
 - how and when these amounts are spent; and
 - reporting mechanisms.
- 2.3 Following discussion the Communities Panel
 - (i) NOTED the situation regarding S106 Planning obligations; and

- (ii) RESOLVED that representatives from Clinical Commissioning Groups responsible for the Council's area be invited to the meeting of the Panel in September 2019.

the need for which has arisen as a result of new development taking place. This funding is commonly known as "s106".
