### **APPLICATIONS FOR DETERMINATION**

The Committee's attention was drawn to the additional information and representations made in respect of applications 19/00646/FUL – Lutterworth and 19/00852/FUL -- Market Harborough.

#### (i) 19/00646/FUL - LUTTERWORTH

Erection of a Class A1 Food Retail Store, with associated car parking, servicing and landscaping (revised scheme). Land Adjoining A4303, Rugby Road, Lutterworth.

#### RESOLVED:

That the application be APPROVED for the reasons set out in the report and supplementary information and subject to a Section 106 Agreement in respect of highway requirements.

### (ii) 19/00852/FUL - MEDBOURNE

Demolition of agricultural buildings. Conversion and extensions to existing farm buildings to form 6 dwellings and extensions to the existing farmhouse. Hinch's Farm, Hallaton Road, Medbourne.

### **RESOLVED:**

That the application be APPROVED for the reasons set out in the report and subject to the planning conditions outlined within Appendix A to the report and the signing of a S106.

### (iii) 19/01900/FUL - MARKET HARBOROUGH

Removal of existing storage shed and erection of 2 dwellings with off road parking and communal side garden. Land Opposite No.10, Harrod Drive, Market Harborough, Leicestershire.

### **RESOLVED:**

That the application be REFUSED as the proposal will be over development of a constrained site and be out of keeping with and detract from visual amenity of Harrod Drive and is contrary to Local Plan policy GD8 d and e.

### (iv) 20/00312/FUL - BILLESDON

Conversion of agricultural building to five dwellings. Land at Church Farm, Gaulby Road, Billesdon, Leicestershire.

#### **RESOLVED**

That the application be APPROVED for the reasons set out in the report and supplementary information and subject to the planning conditions contained in Appendix 1 of the report.

RESOLVED that delegation be given to the Chief Officer Planning and Regeneration to serve an Immediate Article 4 Direction to remove Permitted Development Rights under Part 2 Class A and Part 11 Class B, Schedule 2, Article 3 of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended) for the erection of a means of enclosure on the site and the demolition of the non-designated heritage asset (a boundary wall) to the southern boundary of the site.
