## 325 PORTFOLIO HOLDERS' HALF-YEAR REPORTS

A summary of the discussions on each Portfolio is outlined below:

### Finance, Efficiency and Assets Portfolio (Councillor Spendlove-Mason)

Question/ Comment	Response
The Council received a 'sound' rating for the 2011/12 year. This is to be applauded.	N/A
What is LPI532 concerned with? (this is mentioned on page 6 on the Meeting Papers)	This is a Local Performance Indicator concerned with the rate of interest that the Council receives on savings.

Corporate and Customer Services Portfolio (Councillor Dann)

Question/ Comment	Response
What steps are being taken to monitor the moving of the Council's call centre to Charnwood Borough Council?	A Customer Focus Board has been created. A Member Oversight Board has also been created.
How successful is the Council at making sure that as many residents as possible are included in the District's Register of Electors?	B. Jolly, Head of Corporate and Development Services, agreed to provide information on the Register of Electors to Members.
The report stated that a there had been a reduction in staff sickness at the Council. Are figures available for this?	Councillor Dann agreed to provide a written response to the Commission.
What is meant by" LPI705(i) Top 5% women – Below target"? (referred to on page 9 of the report)	This refers to a national target for half of the top 5% of earners in an organisation to be women. The Council does not currently meet this target.
The report refers to a 'Customer Focus Board'. What is this and what is its function?	This is a group chaired by the Chief Executive. Its function is to ensure that the Council's services are focused on customers. The thoughts of the group are reported to the Executive.
The report mentions the need for Councillors to complete and return a Register of Interests form. What is this and why is it mentioned?	It is a requirement under Section 29 of the Localism Act for Councillors to complete a form disclosing their interests. All Members were reminded that it was their own responsibility to complete this form.

# Health and Community Portfolio (Councillor Holyoak)

Given that Harborough Museum will close for a time while the Symingtons buildings in Market Harborough are refurbished, will the performance indicators for the museum be amended?	This will need to be agreed upon by Leicestershire County Council, Harborough District Council and Harborough Historical Society.
At present the Grants Panel meets only once per year. Is this sufficiently regular to enable communities to access funds?	The Council has recently appointed a Parish Liaison Officer who is currently reviewing this matter.
Are efforts being made to extend the number of youth champions to new areas, for example?	Yes, the Leisure Services Team is currently working on this.
The report refers to Olympic Legacy work.	The Council owns these banners. It has been

Monitoring of Enforcement cases has improved. On average 30 new cases are received by the Council each month and on average the Council closes 31 cases. How is this so?	The Enforcement Team is working to close historic cases as well as new cases.
The 'Joint Action Group' (JAG) is currently under review. Will Members see the results of this review?	Yes, Members will see a see a copy of this document when it is complete. As part of the review, the Police are attempting to create a county-wide approach to JAG.
It is rumoured that new legislation regarding the trading of scrap metals is proposed. Is any information available on this?	Not at the moment. The Portfolio Holder stated that he would advise Members if any information becomes available.
When will ne Dog Control provisions come into force?	These provisions will come into force some time after another public consultation is carried out.
What is the target handling time between the receipt and closure of a Planning Enforcement case?	Ten days.
