## 1 Purpose of Report

#### Background

1.1 As a living document, the Constitution is reviewed regularly to ensure that it remains up to date to reflect good governance as well as any legislative changes that may impact on the interpretation of the Constitution.

#### Governance

1.2 At the meeting of the Audit & Standards Committee (ASC) held on the 2<sup>nd</sup> March 2022, the Committee considered an Exempt report, entitled "Assets Review". This review recommended a number of changes to the Constitution in respect of the Acquisition and Disposal procedures (Part 4, Paragraph O) – these changes are detailed in **Appendix A**.

#### **Sealing of Documents**

1.3 The attesting of the common seal is delegated to "....the Head of Paid Service, or some other person authorised by him or her...." (Constitution, Part 2, Para 14.05), but the Constitution has not been updated to reflect this at Part 5 (a) and (b), the Chairman's and Vice-Chairmans Protocols respective. These changes are detailed in **Appendix B**.

# 2 Reasons for Recommendations

2.2 The Council has to ensure that it has in place a robust Constitution and that it should be reviewed regularly to ensure that all decisions are taken effectively and efficiently within the principles of open and accountable local government. The proposals put forward in this report in respect of:

- Governance (1.2) are as a result of recommendations accepted by the ASC, and
- Sealing of Documents removes an inconsistency within the Constitution and will enable the Council to deliver more efficient services through being able to have more flexible arrangements in the attesting of the common seal which in turn will mean that the decision-making processes will be quicker and more effective.

They made the point that the documents will have been through all the appropriate internal due diligence processes and therefore it is an unnecessary bureaucracy for members to have to make special journeys to sometimes sign one document. They also understand that some local authorities changed this process many years ago.

12.1 The Council has an obligation to keep its constitution under review. The Committee does not have to recommend any of the proposals set out in **Appendix A** or **B** to Council for consideration and adoption.
