1 Outcome Sought from Committee

1.1 Members receive and note the Annual Internal Audit Report and Assurance Opinion for 2016/17.

2 Background

2.1 The Public Sector Internal Audit Standards (the Standards) require the Head of Internal Audit to provide an Annual Internal Audit report and opinion on the overall adequacy and effectiveness of the Council's governance, risk and control framework (i.e. the control environment) that can be used by the organisation to inform its Annual Governance Statement. This report provides a copy of the Annual Report which contains the annual opinion and the basis for this, for the Committee's attention.

3 Assurance Opinion 2016/17

3.1 Based upon the work undertaken by Internal Audit during 2016/17, the Head of Internal Audit's overall opinion on the Council's control environment is that Sufficient Assurance can be given that there is generally a sound system of internal control, designed to meet the organisation's objectives and that controls are generally operating effectively in practice. However, no systems of control can provide absolute assurance against material misstatement or loss, nor can Internal Audit give that assurance.

3.2 Appendix A to this report provides a copy of the Annual Report which includes the Head of Internal Audit's opinion on the Council's control framework for 2016/17 and the basis for this opinion. The opinion is derived from an assessment of the range of individual opinions arising from assignments from the risk-based Internal Audit plan that have been undertaken throughout the year. This assessment has taken account of the relative materiality of these

areas and management's progress in respect of addressing any control weaknesses.

4 Internal Audit Performance

4.1 The report in Appendix A includes details of the delivery of the Internal Audit Plan for 2016/17 and achievement of the service's performance indicators. The team has delivered 100% of the assignments from the agreed Internal Audit Plan for 2016/17.

3.2 The annual self assessment of the Internal Audit service against the Public Sector Internal Audit Standards has concluded that the Internal Audit service operates in general conformance with the Standards. LGSS Internal Audit has also been subject to an external assessment in the last few months.
