<u>Objective</u>: To review the Community Safety Partnership's contribution to reducing crime and disorder in Harborough as set out in the Community Safety Plan.

- 1. Outcome sought from Panel
- 1.1 The purpose of this meeting is to discuss the performance of the Community Safety Partnership in reducing crime and disorder in 2021/22.
- 2 Background
- 2.1 The CSP was set up under <u>Sections 5-7 of the Crime & Disorder Act 1998</u> and is made up of statutory services who need to work together to protect our local communities from crime and disorder, and to help people feel safer. These include:
 - Harborough District Council
 - Leicestershire Constabulary
 - Office of the Leicestershire Police & Crime Commissioner
 - Leicestershire County Council
 - Leicestershire Fire & Rescue
- 2.2 The Responsible Authorities work together to protect their local communities from crime and to help people feel safer. They work out how to deal with local issues like anti-social behaviour, drug or alcohol misuse and Hate Incidents. They annually assess local crime priorities and consult partners and the local community about how to deal with them.

- 2.3 CSPs were set up under Sections 5-7 of the Crime & Disorder Act 1998. There are about 300 CSPs in England and 22 in Wales.
- 2.4 Leicestershire is a two tier area which means there is one CSP for the County (Leicestershire Safer Communities Strategy Board) and one for each of the 7 District/ Boroughs. Harborough district's CSP is called 'the Harborough District Community Safety Partnership' (which can be found on Twitter @HarbCSP). Harborough District Council leads and administrates the CSP on behalf of the 'Responsible Authorities' listed in 2.1.

CRIME & DISORDER UPDATE

- 2.5 Although there has been an increase in overall crime during 2021/22 there had been a large decrease in the previous year due to Covid.
- 2.6 Overall crime in Harborough saw an increase in the Current year to date (YTD) to 5005 (Apr 21– March 22) of +15.6% compared to the Previous YTD 4330 (Apr March 21). However the overall increase from April 19-March 20 of 4894, was only 2.3%.

Harborough North showed the largest percentage increase 21.4% and Broughton Astley the smallest at 6.2%. – see Appendix D for map of beat areas.

Across all crimes and anti-social behaviour Harborough's crime rate is below Leicestershire as a whole and below England's rates for this period

1a. YTD Beat Area Comparisons



The number at the top of each bar on the bar chart shows the volume of all crimes occurring in each bear area between the current YTD (April 2021March 2022). The percentage at the bottom of each bar chart shows the percentage change in total crimes in each beat area from the current YTD compared to the previous YTD (April March 2021).

The Harborough North beat is seeing the highest percentage increase of +21.4% in the number of crimes recorded. No beats are seeing a decrease.

ASB incidents across Harborough District have generally seen a gradual decline with a few small fluctuations throughout the current YTD. There has been a -26% decrease in the total number of ASB incidents in Harborough in this period back to pre-covid levels.

2.7 Harborough District Community Safety Partnership (HDCSP) had 3 key aims for the 2021/22 period which was year 2 of current 3 year plan. These are outlined below.

Cross cutting priorities

- To prevent and raise awareness of the effects of substance misuse
- To increase community engagement and cohesion across the District and reduce fear of Crime.
- Encourage the legitimate sharing of information between agencies.

People

Understanding the causes of violence and coercive behaviour to provide support and interventions for vulnerable individuals and families.

Focussing on:

- Domestic Abuse in particular to work to reduce incidents of violence with injury. Identifying those at risk and use interventions to reduce the risk.
- Exploitation* County Lines and Cuckooing
- Serious Violent Crime Violence with injury
- Racial Hate crime
 - * Exploitation includes all types of grooming including— CSE, County Lines and Radicalisation.

Places

Working with communities to reduce crime and ASB by utilising available powers and resources in a targeted way.

Focussing on:

- Anti-social behaviour including Neighbour disputes and Recreation Areas
- Illegal drug use including Nitrous Oxide/ Cannabis use in residential properties
- Road safety Speeding
- Night Time Economy Recovery plan

Property

To help support and advise our communities on taking personal responsibility, by promoting good practices and using partnership resources to reduce property based crime.

Focusing on:

- Rural Crime including theft, damage and trespass.
- Theft from motor vehicles
- Burglary
- Criminal Damage and arson
- Cybercrime and scams
- 2.8 To support the delivery of priorities, the CSP secured £36073 from the Leicester, Leicestershire and Rutland Police and Crime Commissioner. An Action plan to spend these funds was agreed and delivered Appendix A
- 2.9 Funds were also secured under Safer Streets 2 and Safer Streets 3 Government schemes. See more details in Appendix A & B
- 2.10 A Domestic Abuse Link Worker has been employed for a period of 2 years to ensure we meet our Statutory requirements under the new Domestic Abuse Act 2021 using new funding from the Government of £33k per year.
- 3 Points for discussion
 - To discuss the performance of the CSP,
 - For Members to ask questions of HDC officers and partners on work areas
- 4 Equality Impact Assessment Implications/Outcomes
- 4.1 The partnership actively considers equalities when developing priorities and commissioning services to ensure support for most vulnerable in the community. Supporting vulnerable people is also a key priority as per the Highlight Report.
- 5 Impact on Communities
- 5.1 Crime, disorder and road safety issues are consistent concerns for communities. Harborough District Council and its partners are therefore working to keep the areas we live in both safe and harmonious. This is an ongoing priority of the Partnership and individual agencies.
- 6 Legal Issues
- 6.1 The Police and Justice Act 2006 introduced a requirement for local authorities to have a crime and disorder committee with the power to review or scrutinise decisions made, or other action taken by Responsible Authorities in relation to the discharge of their crime and disorder functions. The responsibilities of the Crime and Disorder Committee are delegated to the Communities Scrutiny

- Panel (Part 3 Section B of the Constitution), which has a duty to review or scrutinise decisions of an actions by the Community Safety Partnership.
- 6.2 The new Anti-Social Behaviour, Police and Crime Act 2014 have consolidated and simplified the powers available to the Police and Local Authorities and in some cases Registered Social Landlords
- 6.3 Local Authorities now have a Statutory Duty as part of the Counter Terrorism and Security Act to have "due regard to the need to prevent people from being drawn into terrorism". The Prevent strategy is a key part of the Government's counter-terrorism strategy and aims to stop people becoming terrorists or supporting terrorism. A yearly Prevent Action Plan is produced and updated.
- 6.4 The new DA Act 2021 places a statutory duty on Tier One local authorities to provide support to victims of domestic abuse and their children within refuges and other safe accommodation. Part 4 of the 2021 Act introduces a new statutory duty on local authorities which places clearer accountability on local areas to ensure the needs of victims within refuges and other forms of domestic abuse safe accommodation are met in a consistent way across England.

7. Resource Issues

- 7.1 Administration of the CSP is carried out by the Community Partnerships Team with HDC being the lead authority.
- 7.2 The work of the CSP is resourced mainly through a £36073 grant from the Police & Crime Commissioner as well as aligning and targeting mainstream resources of statutory partners; mainly the Police, Harborough District Council, Leicestershire Police and Leicestershire County Council.
- 7.3 £5,000 of this fund goes towards the salary of a Community Safety Officer.
- 7.4 In partnership with the OPCC we have also received funding through the Government Safer Streets fund (2&3).
- 8. Community Safety Implications
- 8.1 Delivery against the Three Year Plan is having a positive impact on reducing crime and disorder within the Harborough area.
- 9. <u>Carbon Management Implications</u>
- 9.1 No direct implications. The partnerships consultation strategy places more emphasis on electronic communications and less on printed leaflets/ promotional material etc. This reduces paper, postage etc. Less crime will reduce the number of visits to sites of reported incidents.
- 10 Risk Management Implications

10.1 Overall reductions in resources for the CSP and within CSP partners.

11 Consultation

11.1 The Three Year plan is subject to a consultation period with all responsible authorities on the Community Safety Partnership having the opportunity to contribute.



This annual report looks at the achievements during the 2021-22 period of this plan.

CRIME SUMMARY 2021/22

Although there has been an increase in overall crime during 2021/22 of +15.6%, there had been a large decrease in the previous year due to Covid. Harborough North showed the largest percentage increase 21.4% and Broughton Astley beat the smallest at 6.2%. Main rises were in violent crime and public order, with decreases in burglary and vehicle crime.

ASB incidents across Harborough District have generally seen a gradual decline with a few small fluctuations throughout the current YTD. There has been a -26% decrease in the total number of ASB incidents in Harborough in this period back to pre-covid levels. Across all crimes and anti-social behaviour Harborough's crime rate is below Leicestershire as a whole and below England's rates for this period

Action Plan highlights

People

Domestic Abuse

This year we funded work with the Jenkins Centre for work with perpetrators of Domestic Abuse in the Harborough area, this Countywide project will also run in 2022/23. We also continued to fund a dedicated JADA + worker for Harborough for 20 hours a week, giving specialist domestic abuse support for children and young people who have lived with and experienced domestic abuse. The new Domestic Abuse (DA) Act received royal assent in April 2021. The act places a duty on tier one local authorities (the county council) to provide accommodation-based support to victims of domestic abuse and their children in refuges and other safe

accommodation. It also provides clarity over governance and accountability, requiring tier two councils (district councils), to co-operate with the lead local authority.

The district council achieved additional funding to recruit to a Domestic Abuse Link worker for 2 years to help prepare the council to meet the requirements for the Domestic Abuse Housing Accreditation (DAHA) accreditation, part of the new Act, by March 2023, which will improve the housing sectors response to domestic abuse survivors. This post will work with Housing Services, Community Safety and Safeguarding to provide a linked service to victims and survivors of domestic abuse

We also ran our usual Domestic Abuse campaigns at Valentines and White Ribbon Day. As part of the White Ribbon

campaign we worked with local Hair and Beauty businesses to raise awareness of the signs of Domestic Abuse and gave leaflets and information about ways to seek help.



Protecting vulnerable people

In regard to protecting other vulnerable people in the district the CSP also ran campaigns in support of a number of appropriate weeks of action such as the Unseen campaign for modern day slavey, Anti-slavery Day awareness,

various safeguarding messages during safeguarding month, CSE stop campaign, County Lines Awareness week, sexual abuse awareness week, No More awareness week, alcohol awareness month/week to name a few.

Community Safety Road Shows

Roadshows were offered to all secondary schools in the district during March and April, these included an assembly delivered by the AAA Foundation

(https://www.aaa4success.co.uk) around things such as knife crime, county lines, victim awareness, emotional wellbeing, ASB, consequential thinking & taking responsibility to name just a few. They have real, lived experiences & have young people who have come out of vulnerable lifestyles who deliver these powerful programmes & workshops. The second half was a marketplace approach with stands and activities throughout the day from Community Safety partners such as Police, Fire Service and our own ASB Teams. We also continue to send our termly newsletters to senior schools and promoted the knife crime workshops in the schools Easter term newsletter - last year The Kibworth School, Brook House and Welland Park Academy took part.

Places

Public Space Protection Order (PSPO)

After consultation with partners and the public the CSP added a further public space protection order to our deterrents across the district - this time the PSPO is a condition on all public spaces across the district and it is to prohibit the misuse of psychoactive substances.

Psychoactive substances also known as legal highs are of concern to the community, their misuse often leads to large amounts of paraphernalia also being left around such as nitrous oxide cannisters. These new powers allow the police and council staff to give a fixed penalty notice (FPN) to anyone found using these substances. Our parks

<u>ASB</u>

At the start of 2021, the end of another lockdown saw increased issues in our public spaces as these were the first places to become social areas. Complaints in many parks resulted in extra patrols including the community safety team to give advice and monitor levels of groups in parks with the aims of dispersal. Mobile CCTV was utilised in some of the parks in the short term and additional funding to replace cameras in Little Bowden with a permanent solution. The local impact team were commissioned to work in these areas with young people during this time. The number of warning letters for anti-social behaviour have increased on last year. A pilot at HDC has seen changes in the Community Safety Team creating a joint

enforcement team with Environmental Services to deal with all ASB including fly- tipping.

Throughout the year number of awareness campaigns around respect and tolerate have been run and overall ASB has decreased on the previous year by 26%.

Rural Crime

We held our annual rural crime event in person again this year at South Kilworth Golf Club and had around 40 attendees plus speakers from a number of agencies. There was an introduction from local policing team and the Rural Crime Team, and then a presentation from the LFRS about their new Fire

There have been a few issues for rural communities this year that the partnership has focused on, these include:

- operation Clock was launched across the border with Northants to prevent the Haystack fires seen across the district in previous year although we are still to identify any individuals the number of incidents did not increase on last year and established a new initiative between police and fire for farm yard visits to prevent the risk to this crime.
- Misuse of footpaths due to the ongoing pandemic at the start of the

year, local footpaths and land has been misused as more people took to the countryside - a campaign was run reminding communities of the countryside code, including footpath rights, sheep worrying from dogs and good conduct on other people's land.

- fly grazing - repeated offences of individuals entering fields not owned by them to leave horses in to graze. A couple of operations have been established to try and identify the owners of these horses to take appropriate measures to reduce damage and reassure communities.

Acquisitive crime

Burglary and Vehicle crime incidents continued to decline in the past year and are well below pre covid rates.

Campaigns included theft from van awareness, "Would he Nick it" and "Lock it or Lose it".

Safer streets



We have been successful in securing funding with the Police and Crime commissioner as part of the safer street's initiatives 2 and 3 in our area. £108,000 amount of funding was secured to increase the security of homes in the Lutterworth area. 24/7 Locksmiths carried out security improvements in 468 homes. In addition 155 additional vehicle/bike security packs were distributed worth £13,000. Additional CCTV was also funded under the scheme in Lutterworth.

Under the Violence Against Women and Girls funding we received monies to help increase CCTV in two parks across the district, Welland Park and Warwick Park, Kibworth. A behavioural change campaign was also produced with posters challenging male behaviour has been implemented across parks in the district.

Cyber crime

Covid made more people then ever swap to the internet for shopping, banking, entertainment and socialising. Throughout the year the CSP has not only been raising awareness about staying safe online (safer internet day) but raising awareness about the various and many online scams during the covid pandemic. The CSP ran campaigns about online holiday fraud, romance fraud, general phishing scams, courier scams, Christmas shopping and Black Friday.

Night time economy

Various pubs and bars across Leicester, Leicestershire and Rutland are taking part in the "Ask for Angela" initiative to help you feel safer while out and about. Staff at participating venues have been trained to recognise the discrete safe word, 'Angela', alerting them to a problem. The member of staff can then offer to call a taxi for you, provide a safe place for you to contact a friend, or help you to leave the venue if you are feeling unsafe due to someone else's actions, words or behaviour.

So, if you don't feel safe, if your date isn't who they said they were, or if things just don't feel quite right, go to the bar and ask for Angela.



1. Outcome sought from Panel

1.1 To review and scrutinise the draft Health and Wellbeing Strategy 2022-2027.

2 Background

- 2.1 The health and wellbeing of a person or community is influenced by so many factors, including
 - Personal characteristics including sex, age, ethnic group, and hereditary factors
 - Individual 'lifestyle' factors including behaviours such as smoking, alcohol use, and physical activity
 - Social and community networks and support including family and wider social circles
 - Living and working conditions including access and opportunities in relation to jobs, housing, education and welfare services
 - General socioeconomic, cultural and environmental conditions including factors such as disposable income, cost of living and availability of work.
- 2.2 The Council is in a strong position to influence and support many of these wider determinants of health through the services we deliver. The importance of health and wellbeing to the purpose of the Council is reflected in our new Corporate Plan.
- 2.3 The purpose of developing a Health and Wellbeing Strategy is to help us deliver our new Corporate Plan- working closely with partner agencies to ensure that health and wellbeing is a focal point in Harborough.

- 2.4 The strategy will also support the procurement of a new leisure contract in 2024 by influencing the Procurement Strategy, which will be discussed at the September Communities Scrutiny Panel meeting.
- 2.5 The draft Health and Wellbeing Strategy identifies six cross-cutting strategic priorities for Health and Wellbeing in Harborough District between 2022 and 2027
 - 1. Quality homes for all
 - 2. Community infrastructure
 - 3. Skills, jobs & income
 - 4. Stronger communities
 - 5. Mental health
 - 6. Physical health
- 2.6 The draft strategy has been informed by a strategic review of opportunities and challenges. This included
 - Review of national and local datasets
 - **Appendix B Population Projections**
 - **Appendix C -** Local Authority Health Profile
 - **Appendix D Index of Multiple Deprivation.**
 - **Appendix E –** Engagement Survey results
 - Engagement with residents and partners via surveys and roadshows
 - Review of Team Plans from all relevant departments
- 2.7 The conclusion is that as a district we face a number of challenges. Some of these are universal challenges observable on a national level that all local authorities must tackle, such as the rising incidence of inactivity, an ageing population and the impacts of the coronavirus pandemic, whilst others are more local, such as the limitations in our transport infrastructure and the rural isolation experienced by some of our communities.
- 2.8 To support delivery of the strategy an action plan has been drafted which will be reviewed annually. This is attached at **Appendix F.**
- 2.9 The Health and Wellbeing Strategy and Action Plan will also support the Council to engage in the wider health agenda. The NHS Long Term Plan (NHS England, 2019) is giving a platform for partnership working and integration bringing together local authorities, the voluntary and community sector, NHS bodies and others to look collectively at improving wider determinants for health and meeting the needs of the population they serve. Harborough District Council is part of this new Integrated Care System and part of the

Leicestershire Health and Wellbeing Board which is developing a Health and Wellbeing Strategy for Leicestershire.

OUR DISTRICT

It represents many good things about life – the bustle and friendless of our market towns, the quality of our built heritage and local landscape, the proximity to larger centres for specialist healthcare and services and a relatively safe and tranquil place to live and work.

1. Quality homes for all

Housing conditions are important contributing factors to health. We need to make sure that new and existing housing in the district meets the population needs in terms of availability, affordability, quality, design and function.

We will

- Promote high design standards for new housing
- Improve living accommodation within the district
- Support vulnerable adults and older people to remain independent in there homes
- Provide energy efficiency advice and measures
- Build services and pathways to housing for vulnerable groups

2. Community Infrastructure and services

Access to nature, community places and services can support residents to improve health and maintain a healthy lifestyle. We need to work with partners and local communities to plan and deliver community infrastructure.

We will

- Secure and invest in community infrastructure through the s106 process
- Support the preparation of Neighbourhood Plans and local health and wellbeing objectives
- Work in partnership to ensure green spaces are accessible
- Work in partnership to improve access to canals and waterways

3. Skills, jobs and income

Personal development, having a job and income to meet needs are important contributing factor to health and wellbeing. We need to work with partners and businesses to support training and skill development, growth and jobs in the district.

We will

- Develop training opportunities that contribute towards health and wellbeing
- Local employment average salary levels are sufficient to allow residents to live and work locally
- Ensure advice and support for vulnerable residents to manage debts and access full benefit entitlement/ maximise income

4. Stronger Communities

The communities' people are born, live, work and socialise in have an influence on how healthy they are.
