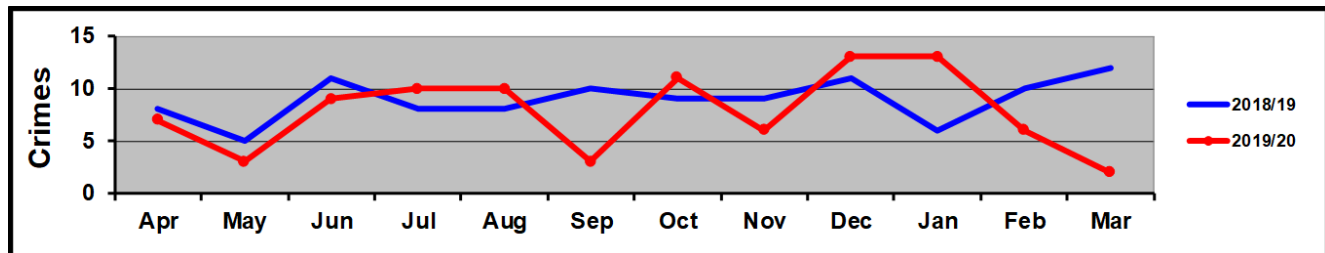

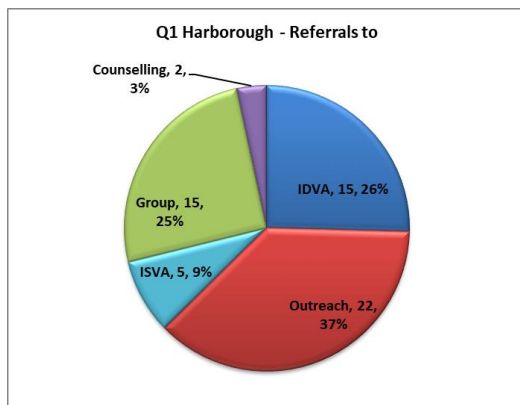

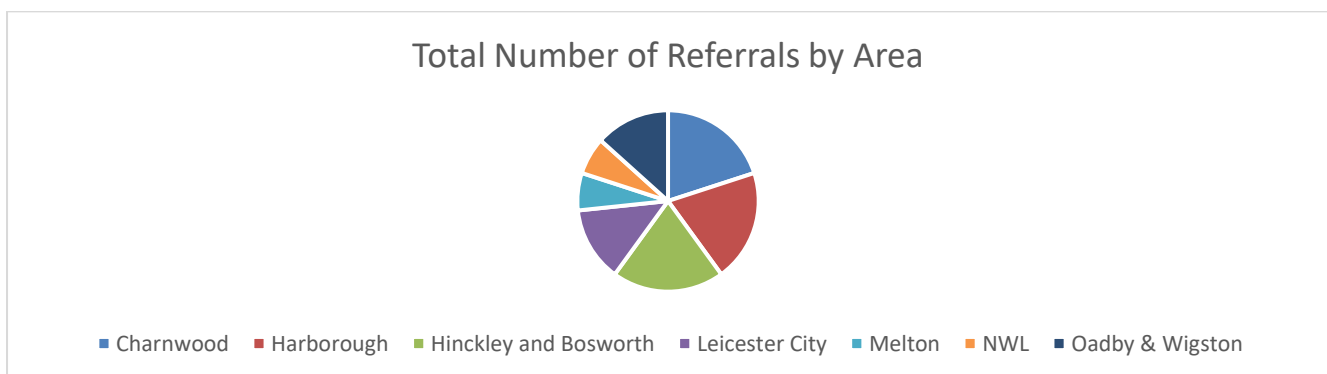

**Position statement**

The Domestic Abuse Dashboard: YTD Quarter 4 2019/2020 shows that domestic violence offences and incidents reported and recorded as offences have increased by 6.7% in Harborough District year to date. All other districts and boroughs within the LLR are showing a decrease

Once again, the data presented by the police on the number of crimes reported, does not reflect the same or even similar increase, this shows a decrease in the crimes of domestic violence with injury being reported.

The only data we have received regarding UAVA (United Against Violence and Abuse) the Leicester, Leicestershire and Rutland commissioned service for supporting all those affected by domestic abuse or sexual violence, is from Q1 19/20, which shows the wait times Harborough District residents may have experienced after contacting the service. Anecdotally, although data has never been provided to support this, the extreme wait time for an ISVA was due to a case not having been closed off properly, not a customer waiting.

JADA+ replace the KIDVA project in October 2020, taking most referrals into the service in the starting month. The pie chart shows that despite Harborough district having a significantly lower population size, it continues to make up the biggest area for referrals into the specialist domestic abuse support. This is why the CSP has continued to look at funding additional support for families, to supplement the services provided by UAVA.

<p>Implement a local campaign and raise awareness of domestic abuse, how to report and what support is available, using variety of media - linking with County campaigns (Campaign Fund)</p>	<ul style="list-style-type: none"> <li>• There is an increase in the number of recorded incidents of domestic violence, as shown in the dashboard, we do not have comparative data from UAVA to show whether there has been an increase in referrals.</li> <li>• In November to support the national White Ribbon Campaign, Harborough District Council Community Safety and Environment Teams worked together to produce a campaign to be delivered to hairdressers and beauty salons across the district on recognising domestic abuse in clients, how to talk to clients about suspected domestic abuse, and where to refer clients or how to report domestic abuse. The campaign was well received across the district, with over 20 establishments visited and presented to. All establishments were given electrostatic posters to put up in their toilets, as a reminder to staff to look out for signs and promote conversation, but also for clients, so the UAVA number can be visible. They were also given mini-pads of the UAVA number, which can easily and discreetly be hidden in a handbag. They were also given a copy of the presentation, which included a reminder of the signs, who to refer to, and further contact details for staff at HDC.</li> </ul>
<p>RARW (Recognising Abusive Relationship Workshop ) sessions in schools –</p>	<ul style="list-style-type: none"> <li>• None this half – we are now looking as to whether this is already addressed in schools, and building new contacts.</li> </ul>
<p>JADA + is a Journey Away from Domestic Abuse. It is a service that offers advice, assistance, emotional and practical support. As well as this, JADA+ offers information for children/young people and the non-abusing parent. JADA+ works towards a child centred approach to give children and young people a voice. We take their views and opinions seriously and we place their needs at the centre of all the support being offered.</p>	<p>One of the reported benefits of having a dedicated JADA+ worker is in the levels of engagement because there is a very small waiting list. In other areas there is a higher proportion of disengagement from service after waiting ‘too long’ for support.</p> <p>7 children were supported between October 2019 and December 2019, each child was given 11 sessions over an 11 week period.</p> <p>Support from JADA+ is normally provided in a school setting, however, with COVID 19, and the lockdown which came in mid-March 2020, there was a move to look at contingency plans for provision of support.</p>
