- the (+1) refers to the non-voting position of the Chairman of Scrutiny Commission as ex-officio to the Scrutiny Panels and, as a non-voting capacity, is not considered in the political balance of the Scrutiny Panels.
- Although a single party member is not entitled to any allocation of seats under the regulations, political groups are not entitled to have more than their allocated share of seats. It is up to the Council to determine how the remaining 2 places are filled by a Councillor not in a group. This is a decision for full Council. The legislation is often interpreted that a single group councillor is entitled to fair representation
