To consider and agree the updated delegations, as noted in Appendix A, in relation to the Regulatory Committee, Section B of Part 3 of the Council's Constitution.

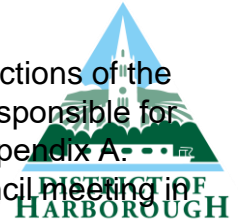
2. Background
