Fix Penalty Notice under the Anti Social Behaviour Crime & Policing Act

The Anti-Social Behaviour, Crime and Policing Act 2014 gives the Council new powers to protect local communities. The powers are wide ranging and relate to a number of different Council services and functions. On the 3rd November 2014 the Executive committee granted delegated powers to the Corporate Director (Community Services) to take action under the relevant parts of the act. Failure to comply with a Community Protection Notice or a Public Spaces Protection Order may result in the serving of a fixed penalty notice. The Act set a limit of £100 for the level of fixed penalty notice that can be issued. The Leicestershire Enforcement Forum have undertaken a benchmarking exercise to determine the approach for setting the level of fixed penalty notice and the consensus across Leicestershire was to set the level at £100. People issued with a fixed penalty notice would have 14 days to pay and if paid within 10 days a reduced level of £50 would apply
