Sundry Debt Collection Performance Report

Exchequer Services

This Section is responsible for raising and issuing sundry debt invoices for this Council on behalf of other service areas. They also issue the first reminder notice when payment has not been made.

The Sundry Debt Officer is responsible for the enforcement and collection of this debt. The officer issues follow up reminder notices as well as setting up payment arrangements. For debts that remain outstanding these are referred to the Council's bailiff for collection.

Amount due in respect of Section 106 income this is monitored by the Council's Section 106 Co-ordinator.
