Market Harborough

Harborough District, situated in the heart of the Welland Valley in rural south Leicestershire, is well known for its rolling countryside, picturesque villages, historic market towns, and unique independent shops. The town of Market Harborough is home to the award-winning Harborough Market.

With a population of around 85,000 and around 37,000 homes, the main settlements are Market Harborough, Lutterworth and Broughton Astley. There are more than 90 villages – many with populations of less than 200.

The District is one of the most sought after places in which to live in the East Midlands with property prices remaining strong, leading to increased demand for new housing, services and facilities.

The District regularly features in 'best places to live' surveys in national publications – due to it being relatively affluent with low crime rates, low unemployment, high owner-occupancy, high skills levels and above average earnings. It has good schools, and accessibility to larger towns and cities, the M1 motorway and direct rail links to London.

High streets remain vibrant with the local business community relatively resistant to national economic challenges. Independent shops attract business from far and wide, whilst dynamic and exciting community

events attract visitors and harness the abundance of community spirit. We work hard to encourage business and economic benefits, promote training and apprenticeships, and work with partners to open up new funding streams.

Harborough District has a high number of home-based businesses supported by recent investment by the Council in Superfast Broadband.

The District retains a strong sense of heritage and character, boasting a number of tourist attractions including Foxton Locks – one of the most popular destinations in the East Midlands – Kilworth House open-air theatre, Wistow Maze and a number of inviting country parks, cycle routes, and family play areas.

Harborough Museum houses the internationally important Iron Age and Roman finds known as the Hallaton Treasure, whilst Lutterworth Museum showcases the pioneering work of jet engine inventor Sir Frank Whittle.

Work is ongoing to make better use of our property assets, by continuing to redevelop Council-owned garage sites to provide housing, and by leasing out space within our headquarters at The Symington Building. This has created a vital source of revenue benefiting Council services and taxpayers as a whole.

Key achievements for 2016 – 2017

Priority

Working with communities to develop places in which to live and be happy

We have...

- Engaged with communities in the development of the Local Plan via a series of interactive consultation events.
- Supported a number of parish councils through the Neighbourhood Plans Process, and held referenda to enable residents to vote on proposed plans as well as supporting 24 other parish councils in early the early stages of developing Neighbourhood plans.
- Seen over 20,000 attendances at activity sessions by residents from all age ranges across the district.
- Commissioned an options appraisal for the future of the Council-owned leisure centres.
- Raised awareness of child sexual exploitation across all secondary schools (1,700 pupils).
- Purchased a new deployable camera with infrared functionality for use in antisocial behaviour hotspots.
- Undertaken training with parishes on enforcement and community emergency plans.
- Launched a fly tipping campaign called 'Tip-off'.
- Supported the need for redevelopment of Harborough Railway Station.

...during the 2016/17 year Harborough District Council secured over £9.6 million of Section 106 funds and allocated over £200,000 to community projects.

Key achievements for 2016 – 2017

Priority

Enable public services which are effective and deliver value for money

We have...

- Kept Council Tax low (0% increase on the previous year) and still delivered value for money.
- Successfully launched a chargeable green waste collection service to which over half of the district subscribed.
- Worked with partners to develop a growth plan for the County and City areas which will support growth in economy, jobs and homes.
- Worked with partners to develop a Combined Authority to promote economic growth.
- Submitted an Efficiency Plan to central government which demonstrates the Council's commitment to reducing costs and increasing income, resulting in securing funding for four years from central government.
- Adopted a new Car Parking Strategy which aims to meet the needs of residents, businesses and visitors to the District.
- Generated capital receipts and reduced running costs through effective estate management.
- Submitted a preferred option to the Local Government Boundary Commission for England on the future size and boundary arrangements of the Council to reduce number of Councillors from 37 to 34.

Encourage a vibrant and sustainable business community intent on prosperity, employment and learning opportunities

We have...

- Provided £40,000 to businesses to initiate apprenticeships.
- Directly employed two apprentices, one of whom was a regional winner of the East Midlands Intermediate Apprentice of the year.
- Supported a range of community events across the District, to encourage visitors, including: Harborough by the Sea, the Christmas Fayre, Arts Fresco, and Harborough in Bloom.
- Won a Best Small Indoor Market award for Harborough Market.
- Launched the 'Explore Harborough' website to enable visitors to identify attractions in the District.
- Achieved over 90% coverage of the District with Superfast broadband.
- Supported local businesses with broadband infrastructure through issuing vouchers.
- Continued to work with the Superfast Leicestershire Broadband programme to secure funding for access for the remaining 10% of residents who can not yet connect.
- Launched a new Business Support programme 'Pioneer 10' which has already supported over 400 businesses across the district.
- Submitted bids for external funding to support the growth of small and medium enterprises in Harborough District.
- Due to high levels of economic growth in the District, retained a high level of business rates to support Council Services.

Key achievements for 2016 - 2017

Priority

To support the vulnerable in the community where they live

We have...

- Helped over 1,400 vulnerable people stay their own homes safely through provision of the 24-hour, 365-day Harborough Lifeline service.
- Worked with the owners of empty properties to encourage empty properties to be brought back into use.
- Issued notices to landlords in cases of poor housing conditions.
- Worked with our public sector partners to support families in need.
- Successful implementation and transfer from Housing Benefits to Universal Credit.
- Provided Housing advice to over 300 households which helped to prevent homelessness.
- Promoted access to advice and benefits.
- Provided core grants to Citizens Advice Bureau, Voluntary Action South Leicestershire, Lutterworth Volunteer Centre and One-Stop Shop.



Did you know...

During 2016/17 year the Council invested over £300,000 and worked with partners to ensure that vulnerable people remained in their own homes through disabled facility grants and improved co-ordination by housing and social care agencies.

- Work in partnership to address crime and anti-social behavior and support vulnerable people.
- Submit for examination a new Local Plan to promote sustainable development, meet housing and employment needs, and protect open space.
- Continue to support communities to help them deliver Neighbourhood Planning.
- Continue to allocate funds for community projects.
- Reduce carbon emissions by continuing to promote domestic energy efficiencies.
- Tackle fly-tipping through publicity campaigns and enforcement.
- Undertake a District-wide survey of residents to inform the Council's priorities.
- Support the Syrian Vulnerable Persons Resettlement Scheme along with other Districts in Leicestershire.
- Reduce the impact of incidents of flooding through working with partners.
- Work with communities and parishes in the implementation of tougher enforcement powers (dog control, public drinking etc.).
- Implement the revised Housing Strategy to enable the right mix of housing.
- Ensure supply of existing and new affordable housing lettings are targeted to those most in need.

Managing the Council's finances 2017 - 2018

Planning for the future

Over many years the Council has successfully managed its finances and has managed to maintain the delivery of quality services despite significant reduction in Central Government Funding since 2010. As a result of efficient and effective budget management and a three-year Medium Term Financial Strategy it has been possible to freeze or reduce Council Tax over the past six years.

Funding for Local Government is expected to change dramatically with the potential removal of the Central Government Grant by 2018 and the requirement in the future for councils to rely on income from Council Tax, Business Rate Growth, New Homes Bonus and charging for services. Across Local Government the transition to the new funding mix is challenging. However, since 2013 the Council has been the highest recipient per head of population of retained business rate growth and new homes bonus. A local plan will be issued in 2017 setting out the Council's plans for housing and economic growth up to 2031.

The Council is forecasting £3.3 million of additional funding pressures by 2019/20 arising from Government funding reductions and unavoidable cost pressures. In addition to the maximisation of business rates, Council Tax increases



going forward and receipts from building houses there is a need for the Council to make efficiencies or generate additional fees and charges in excess of £¾ million by 2019/20. The 2017/18 budget makes a positive start on delivering this target with over 50% of the efficiency gap being delivered in year one of the three years.

The Council has been successful in securing guaranteed Government funding to 2019/20 through the adoption of an Efficiency Plan. Our focus will be on improving outcomes for residents but we will not necessarily be the provider or funder of services in the future. The Council aims to ensure services that meet the needs of the local people at the right time and are affordable for tax payers and residents.

The next few years are expected to remain challenging and will be subject to volatility and change. The Council is confident that its financial strategy will allow the next three years to be managed in a planned way.
